

Reference to Product Category (产品类型参考)

This reference gives examples for building a product group for certification under the same product category.
(此产品类型参考举例说明如何将同属于同一产品类型下的产品归纳为产品组。)

Yarns & Fabrics

Yarns or Fabrics made from the same kind of fiber material can be combined into one group of products:

- Cellulose fiber (cotton, linen, flax, viscose, Lyocell, bamboo, etc., or blends of these fibers)
- Protein fiber (wool, silk, mohair, cashmere, etc., or blends of these fibers)
- Synthetic fiber (polyester, nylon, acrylic, etc., or blends of these fibers)
- Leathers or leathers composites

Yarn or fabrics manufactured according to same technology can be combined into one group of products:

- Products manufactured using the same processing technologies, like polyester and acetate fiber dyed with disperse dyestuffs or cotton and cotton/polyester dyed with reactive dyestuff with only the cotton part dyed

Trimmings

Trimmings made from the same kind of fiber material can be combined into one group of products:

- Cellulose fiber (cotton, linen, flax, viscose, Lyocell, bamboo, etc., or blends of these fibers)
- Protein fiber (wool, silk, mohair, cashmere, etc., or blends of these fibers)
- Synthetic fiber (polyester, nylon, acrylic, etc., or blends of these fibers)
- Leathers or leathers composites

Trimmings manufactured according to same technology can be combined into one group of products:

- Products made using the same processing technologies, like polyester and acetate fiber, dyed with disperse dyestuffs or cotton and cotton/polyester dyed with reactive dyestuff with only the cotton part dyed

Accessories

Accessories made from similar main materials can be combined into one group of products:

- Metal
- Synthetics
- Natural materials
- Glass

Assembled products

- Assembled products for the same application could be combined into one group of products, like clothing for babies;
- Assembled products made from pre-certified materials could be combined into one group of products;

纺织类辅料

- 蛋白质纤维(羊毛、丝、马海毛、羊绒等,或是由这些纤维组成的混纺产品);
- 合成纤维(涤纶、尼龙、腈纶等或是由这些纤维组成的混纺产品);
- 皮革或是由皮革组成的复合产品

非纺织辅料

由相同或相似的主要材料组成的非纺织辅料可以组成一个产品组:

- 金属
- 合成材料
- 天然材料
- 玻璃

制成品

- 由相同应用目的制成的不同制成品可以组成一个产品组,如:婴幼儿用的服装;
- 由已经获得 Intertek 生态产品认证的原材料制成的不同制成品可以组成一个产品组。
